10.14.08 REPORT OF THE SUB COMMITTEES.

Sports Field

Councillor John reported that due to the inclement weather there has been little activity on the Sports Field as many football fixtures have been cancelled.

Village Hall

Councillor John reported that an inspection of the electrical wiring including emergency lighting and fire alarm systems had identified a number of issues. It was agreed that the person who carried out the inspection be invited to discuss the matter with the Council prior to any work being carried out.

It was noted that toilet floor requires to be replaced following the recent blocked drain. It was agreed that the drain cover will need to be raised in order to provide access in the event of any future occurrence.

It was noted that an estimate for new flooring in the main hall has been requested together with a full specification of the work to be carried out so that further quotations can be obtained on the same basis.

Councillor John reported that work on installing the new barrier will be completed shortly, and work on the disabled access ramp for the boiler room is also due to start in the near future.
